22 to the Supreme Court of the State of Arizona from the Court’s rulings contained in the Minute
23 Entry entered on June 23, 2014, which granted the Respondent-Defendants Motions to Dismiss
24 based upon disputed determinations of proper service on defendants and disputed determination
25 of indispensable parties to the action, and that therefore denied Morgan a determination on the
merits in violation of his rights to due process under the United States and Arizona Constitutions,
as well as a timely determination of all issues arising from the challenge to the sufficiency of
nominating petition signatures and that the government may not deny a benefit to a person on a
basis that infringes his constitutionally protected interests — especially, his interest in
